

## BIG Summer Read Terms and Conditions

Your contact information will be retained by Greater Dandenong Libraries to be used only for the purposes of this competition. If you wish to keep your competition entries, please retain a copy as it will not be returned.

**Submission of an entry is deemed acceptance of the following terms and conditions:**

### 1) Entry eligibility

- Entry is open to all children from 4 – 12 years of age in Victoria
- To enter you must have a library card number
- An entrant must be an individual and not a group or organisation

### 2) Entry details

- Entrants must register their interest by completing the online registration link on Greater Dandenong Libraries website:

Or contacting the library on 1300 630 920 or attending a branch and registering on website with the assistance of staff

- All fields in the submission of entries must be completed and permission granted by a parent or guardian including an email address or contact number
- Entries must be submitted within the competition period and received by **9pm, Wednesday 31 January 2025** (close of competition)

### 3) How to enter

- Entrants must first register for the BIG Summer Read either online webpage, by calling the library on 1300 630 920 or at the library branch
- At a minimum, 10 books must be read and logged on the website to be eligible for prizes
- All fields in the submission of entries must be completed and permission granted by a parent or guardian
- Entries must be submitted within the competition period. Competitions close **9pm, Wednesday 31 January 2025**

### 4) Prizes

- To be eligible for a prize, entrants **must** be Library Card Holders at Greater Dandenong Libraries

- To be eligible for a prize, entrants must log a minimum of 10 books on website
- Winners of the BIG Summer Read will be presented at the Grand Finale event at **2pm, on Saturday 8 February 2025**
- Should a prize remain unclaimed and the library has made every effort to contact the winner with the information provided on the entry form, or should the winner not wish or not be able to accept a prize, the prize will be awarded to the runner up. The runners up will only be notified if they have won a prize
- If a prize becomes unavailable, Greater Dandenong Libraries reserves the right to provide a similar product, subject to any applicable laws and or written directions
- The prizes are not transferable or exchangeable and cannot be taken as cash or other incentives

#### 5) Judging

- Entries will not be judged, winners will be chosen based on eligibility by Public Libraries Victoria
- Selection of prize winners will be final, and no correspondence will be entered into.

#### 6) Announcement and distribution

- Winners will be notified by **Friday 7 February 2025** and officially announced at the Big Summer Read Grand Finale **2pm, on Saturday 8 February 2025**
- Prizes will be presented at the Big Summer Read Grand Finale **2pm, on Saturday 8 February 2025** or can be made available for collection from the library at an agreed time and date

- 7) Greater Dandenong City Council and its Libraries reserve the right to retain, duplicate, display and publish the entry online. Only first names and ages will be published.
- 8) Entries will not be returned. Every care will be taken but the organisers do not assume responsibility for loss or damage. Please retain a copy of your entry.
